# **1. Name of the trust:** SUDHAKARRAO KULKARNI SMRUTI PRATISHTHAN, PANGAON, TQ. RENAPUR DIST. LATUR 431 522 (MAHARASHTRA)

# **3.** Aims and Objectives of the trust:

# 1. Activities in the field of education

- Establishment of regular / occasional / permanent educational and instructional centres for spreading education in the rural and remote areas (e.g. pre-primary, primary and higher schools, colleges, training centres, schools for downtrodden, mentally / physically disabled, deaf and dumb children, skill training centres like sewing, fashion designing, nursing, laboratory technician, pharmacy, courses, colleges for social sciences etc.)
- 2. Establishment of need based knowledge and technology centres like training centres and colleges in computer sciences, agriculture, horticulture, flori and pisci- culture, vermiculture, organic farming, Krushi VIdnyan Kendras, Livestock and dairy development etc. for entrepreneurship development.
- 3. Organization of training / special instructional camps (for personality development, oratory, dance, drama, summer / winter camps of youth, writing, drawing, arts, exposure to folk cultures, skill development, civic studies, competitive exams, excursions, *shram-sanskar*, social awareness etc.) for teachers and school / college students in rural and urban areas.
- 4. Organization of awards and provision of platform / forum to the teachers and eminent workers in the field of education.
- 5. Review, research and advice to the concerned authorities, departments, ministries regarding curricula and various aspects of education.
- 6. Organization of training and orientation programmes for the students, teachers and parents.
- 7. Publication of journals, pamphlets, periodicals on regular / occasional basis.
- 8. Organisation of conventions, conferences, seminars, symposia, workshops, lectures of eminent speakers for various issues in the field of education.

- 9. Participation in govt. / non govt. Programmes, strategic plans and schemes, in the field of education, with an objective of spreading education in the rural and remote sectors.
- 10. Provision of aid, expertise and advice in support of the govt. / non-govt. organizational projects, in the field of education.
- 11. Publication of surveillance and other reports, observations and studies, pertaining to the upheaval of education.
- 12. The official responsibility of new section Pangaon chapter of MARATHI VIDNYAN PARISHAD, will be with the Executive Body of the Trust. The Executive Body will also keep the right to approve and modify the constitution of Pangaon chapter of MARATHI VIDNYAN PARISHAD. (Annexure)

# 2. Objectives in social activities

- 1. Survey and study of local problems and predicaments of common folk in the rural and remote areas.
- 2. Organisation of programmes for awareness, deaddiction, subsistence, self employment, health and social / environmental issues among economically backward and downtrodden folk in the area.
- 3. Implementation of special health care activities through mobile, regular / temporary / permanent health centres / units, medical research and care units, HIV irradication and awareness, actions against infanticide, provision of clinical ambulances, immunization and vaccination programmes, rehabilitation of HIV / AIDS affected people, experts guidance and consultation, organization of health care, diagnosis camps, provision of aids (like JAIPUR FOOT, wheel chairs, spectacles / goggles etc.), provision of foods and supplements to deprived ones, arrangements of lectures and guidance camps etc.
- 4. Organization of programmes for awareness and guidance of health, nutrition and subsistence for the poors, scheduled castes, women, seniors and the deprived ones.
- 5. Organization of programmes for cooperation, support, guidance and awareness for entrepreneurship, small scale industrial trainings and overall development of the youth, children, HIV affected children / youth in rural, remote, neglected areas.
- 6. Organization of programmes for awareness towards current, advanced and innovative technologies and their implementation in agriculture, dairying, farming, fishery and allied rural fields.
- 7. Organization of programmes for surveillance and resolving the basic needs of day to day life of poors and the deprived classes.
- 8. Organization of programmes for surveillance and seeking solutions for subsistence and fulfilling the basic needs of day to –day life of rural and neglected classes.

- 9. Organization of programmes for provision of opportunity and scope to the hidden skills, creative art, talent and inert capacities among deprived, scheduled, backward, rural, nomadic classes towards their subsistence and capacity building.
- 10. Organization of programmes for the rehabilitation, moral upheaval, de-addiction, civilization, character building, constructivism, creativism, activism, awareness among the rural, unemployed, dropped outs youth and children, HIV affected children / youth in rural, remote and deprived, neglected areas, urban areas.
- 11. Organization of programmes for awareness of information and technology, skill development in corporate sectors, provision of talent searching opportunities and further support towards nation and society building.
- 12. Organization of meets, village gatherings, conferences, conventions, summer / winter camps for youth exchange and rapport / dialogue development for reducing the rifts, fairs, sports, discussions and debates etc among rural and urban youth and folk.
- 13. Implementation of schemes and projects for rural health, cleanliness, watershed development, community wells, community ponds / sheds / farming / check dams etc.
- 14. Provision of support systems and establishment of shelters to the seniors (VRUDDHASHRAM etc.), child and infant care units, orphanages for the rehabilitation of children in deprived classes, labourers, sex workers etc. Women empowerment, rehabilitation, self employment, income generation etc.
- 15. Implementation of various govtal. / non govtal. / voluntary schemes for the rehabilitation and empowerment of destitute women, ex-sex workers, widows, deprived ones.
- 16. Implementation of IDEAL VILLAGE Schemes, environment awareness programmes, farmers meets, fodder camps in draught prone areas, soil conservation and enrichment programmes, GOSHALAs (shelters to the deprived and destitute animals), trainings and support to organic farming through the govtal. / non govtal. Schemes, community dairying and allied industry occupation building programmes etc.
- 17. Implementation of movement against the taboos and misbelieves
- 18. Development, construction, repair / rebuilding and reincarnation of the community places of common use in the villages (like market place, meeting halls, social community halls, graveyards, sports centres, cultural halls / centres, entrance gates, function halls, libraries, public toilets / urinals, schools / colleges through cooperation, contribution, sponsoring or else as per the situation, demand and resources.
- 19. Development of special facilities like livestock markets, dispensaries, animal health care units, soil testing laboratories / mobile facility, animal feed and fodder schemes, awareness and training of generation of animal feed and fodders, advanced management systems, mitigation systems, disaster management systems etc. awareness and availabilities of advanced techniques like artificial insemination, surrogation, cross breeding etc. Organization of livestock exhibitions, agricultural exhibitions etc. for extension of knowledge and technology.

- 20. Implementation of govt. / non govt. schemes for the overall development, subsistence, support and upheaval / income generation among the children, seniors, women, deprived people and youth.
- 21. Provision of aid and support of various kinds during the calamities and disasters (floods, quakes, fires, accidents, epidemics, draughts, food / water scarcities etc.).
- 22. Organization of exhibitions, excursion tours of villagers for the awareness towards deaddiction, health, various farming systems in various climatic conditions, exchange of technologies etc.
- 23. Implementation of surveillance and relevant projects for the proper utilization of various resources across the geographical and social areas for nation and society building, capacity building among the folks.
- 24. Organization of projects to co-implement between rural and urban youth through exchange of cultures and resources for integration and fraternity.
- 25. Implementation of various programmes for social and communal harmony through awareness camps of youth and children towards social harmony, civic sense, moral character, good behavior, mannerism and etiquettes, judicious use of tools and techniques in advanced era (e.g. internet, mobiles, kindle devices etc.). implementation moral cyber and traffic management, law and order, civil and social regulations, traffic regulations for traffic harmony, ACCIDENT FREE programmes sectorwise etc. in cooperation and concurrence with the govt. organizations and authorities.

# 3. OBJECTIVES IN CULTURAL ACTIVITIES

- 1. To organize activities for conservation and development of cultural movement in rural and urban sectors through encouragement to the amateur artists in the fields of music, thatre (drama), films (movies), architecture, sculpture making etc. by organizing trainings, exhibitions, performances, conventions, festivals etc.
- 2. Organization of charity shows (of dance, vocal and instrumental music, dramas, movies, sports, skills, lectures, trainings, conventions etc.) and other events in cultural field, with participation fees and charges for both the upliftment, introduction of professionals performances, as well as the generation of funds and source of finance for the Trust (enabling the Trust for furtherance of activities).
- 3. Purchase, acquirement, maintenance, repair of the machinery and equipments for effective, self reliant and saving expenditure (on hiring the same from private vendors), essential for organization of shows and other activities of theater, cinema, dance, music and other cultural skills and arts.
- 4. Organization of conventions, debates, festivals, seminars, lectures etc. in the fields of art and literature, linguistics etc. separately, as well as in joint ventures with other govt. and non govt. organizations.
- 5. Organization / participation in organization of conventions, workshops, seminars, symposia, lectures of eminent workers in the fields of literature, arts, music, poetry / gazal recital, competitions etc. independently or in alliance with govtal. / non govtal. Organizations / institutions. (A separate activity GAJHALMALA' may be initiated.)

# ANNEXURE C

# SUDHAKARRAO KULKARNI SMRUTI PRATISHTHAN, PANGAON TQ. RENAPUR DIST. LATUR RULES AND REGULATIONS

# 1. TERMS / WORDS AND DEFINITIONS :

The following are the definitions of the terms used in text.

a. Executive Body	:	means the body of Life Members, elected for execution and actual processing of the trust.
b. Jurisdiction	:	means the geographical area over which the trust will execute its activities.
c. Income of the Trust	:	means all the financial earnings owned by the trust, including the amount received in donation received for special purpose or otherwise and the estates, in the name of the trust.
d. Member	:	means any Indian individual (by birth), who will abide by the rules and regulations, accepted as 'Member' after approval by the Executive Body of the trust.
e. Financial Year	:	means the span of days in 12 months starting from $1^{st}$ of April of the year to the $31^{st}$ of March of the next calender year.
2. Jurisdiction	:	Maharashtra State
3. Year of Accounts	:	1 <sup>st</sup> April to the next 31 <sup>st</sup> of March (of the next calendar year).

# 4. Member and their registration fee :

Any Indian individual, by birth, who agrees to abide by the rules and regulations of the Trust becomes the Member of the Trust, on approval of the application and payment of the prescribed fees.

# 5. Types of Membership

# a. General Body Member :

:

Any individual, Indian by birth, can be the General member of the Trust on payment of Rs. 500 /- (Rupees five hundred only), or more (upto Rs. 11,000/-) till  $31^{st}$  of March in the current year.

# b. Life Member :

Any individual, Indian by birth, can be the Life Member of the Trust with the approval of the Executive Body, on payment of Rs. 11,000 /- (Rupees eleven thousand only) or more, in two equal installments.

# c. Doner Member :

Any individual, Indian by birth, can be the Doner Member of the Trust on payment of Rs. 50 /- (Rupees fifty only) or more, at one time, as donation. The individual on payment of Rs. 11,000/- or more will be honored as the 'Life Member (Doner)', on approval by the Executive Body, without any liabilities and rights (particularly to vote), of the other Life Member.

# 6. Cancellation of the Membership :

The Membership of the Trust will come to an end -

- 1. On execution of any criminal charge to punishment
- 2. On committing any immoral act
- 3. On consensus approval by the Executive Body after noticing and establishing any act, against the Trust or its rules, regulations, tenets or well being of the Trust.
- 4. On remaining absent for three consecutive meetings, without notice. (The membership of such a member will be cancelled with the approval of the Executive Body, which will keep the right not to cancel the membership, under certain circumstances.)

# 7. General Body and its rights :

- 1. General body should meet within a period not more than three months after the financial year.
- 2. All members can participate in this general body meeting.
- 3. Defaulters and Members, who have not completed one year of membership, can remain present for the meeting, but will not be entitled power of voting / right to participate in the consensus on any issue.
- 4. Monitor the activities of the Executive Body.
- 5. Approval to the accounts.
- 6. Planning and approval to the budget of the next financial year.
- 7. Approval to the proposals and resolutions submitted with the permission of the Chairman.
- 8. Election / selection / appointment of the Executive Body.
- 9. A General Body meeting should be arranged by the Chairman, within **ten** (10) days, if proposed by <u>ten (10)</u> Executive Body Members, in the interests of the Trust.

# 8. Notice of the General Body and quorum :

Notice should be issued fifteen days before, by registered post or direct communication or considering the expenditure, time and efforts required – by electronic media messages (e.g. SMS, WhatsApp message, Email etc.) alongwith the date, venue, time and the agenda. The same will be displayed on the notice board of the office of the Trust. At least two third  $(2/3^{rd})$  of the total strength of all types of Members will be conditional as quorum for the meeting, otherwise the meeting will be conducted after half an hour, without quorum.

# 9. Special General Body Meeting and its duties :

A special General Body meeting will be called by the Chairman and the Executive Body on need or also within a month of receiving proposal in written delegation by 2/3<sup>rd</sup> of the Members. The Secretary should issue such a notice by registered post or direct communication or by electronic media messages (e.g. SMS, WhatsApp message, Email etc.), 10 (ten) days before the scheduled date. The Special General Body meeting will be called for the special purpose only and no other issue than the proposed agenda will be discussed in it.

# 10. Executive Body, Designations and Constitution :

The Executive Body shall consist of minimum 07 (seven) and maximum 21 (twenty one) members. The Designations of the elected Executive Body will be as follows :

# 11. The Term and Election of Executive body :

- a. The Executive Body will work for a term of five (5) years.
- b. The Executive Body will be elected in General Body Meeting after every five (5) years.
- c.
- 1. Defaulter member of any type / form will not be eligible for election
- 2. The Election Officer will be appointed 21 days prior to the date of elections.
- 3. The election will be conducted with secrecy and confidentiality.
- 4. Right to vote will be to only the member(s), after one year of membership.
- 5. The date of election will be notified 15 days before, through office notice.

# 12. Executive Body Members and their duties :

# a. President / Chairman :

To Chair the meetings and issue orders in the interests of the Trust. Monitor and supervise the implementation of activities of the Trust and its branches. To invite a General Body Meeting, in case the Secretary fails to do so, for any reason.

# b. Secretary :

Assistance to the President / Chairman and execution in absence of the President / Chairman.

# c. Deputy Secretary :

- 1. Arrange and invite the Executive Body meetings, as per instructions.
- 2. Execute the correspondence of the Trust.
- 3. Rule out the grievances, if any.
- 4. Carry put court matters and other official activities, in the interest of the Trust.
- 5. Monitoring and supervision of the activities of the Trust.
- 6. Approve and sign on daily accounts of the Trust.
- 7. Guidance, supervision, monitoring of the duties of the sub-ordinate staff.
- 8. Implementation of the resolutions approved in the meetings.

# d. Treasurer :

Monitoring the financial status of the Trust.

To write or execute the accounts of the Trust and present the same to the Secretary. Planning and preparation of yearly accounts statements on the basis of daily accounts.

Presentation of accounts statements to the Auditor and execution of the audit paras.

# e. Members :

To participate and cooperate in the various activities, meetings, elections of the Trust.

# 13. Executive Body Meeting and its Demand :

The Executive Body should meet at least once in three months. The Chairman should invite a meeting within three days, on receiving a demand from at least  $2/3^{rd}$  of the total Executive members.

# 14. Notice of the Executive Body and Quorum :

The notice of the Executive Body will be issued at least seven (7) days before by registered post or by direct communication or by electronic media messages (e.g. SMS, WhatsApp message, Email etc.). The meeting will be conducted with a quorum of  $2/3^{rd}$  of the total members, failing which the meeting can be conducted after half an hour, without condition of quorum.

# **15.** Rules for the Executive Body election :

- 1. Defaulter member of any type / form will not be eligible for election
- 2. The Election Officer will be appointed 21 days prior to the date of elections.
- 3. The election will be conducted with secrecy and confidentiality.
- 4. Right to vote will be to only the member(s), after one year of membership.
- 5. The date of election will be notified 15 days before, through office notice.

# 16. Filling the vacant post in Executive Body :

The resignation, if any, should be submitted to the Chairman, which should be approved by the Executive Body further. The membership will remain till the approval by the Executive Body. The vacant seat, due to resignation or bereavement of the member shall be filled in through the Life Members, by the approval of Executive Body in consensus.

# 17. Duties and responsibilities of the Executive Body :

- 1. The Executive Body should meet at least once in three months.
- 2. The Chairman should call a meeting at any time, within seven days after receiving letter in demand from five (5) members of the Executive Body.
- 3. The Executive Body shall keep liaison over the activities of the Trust.
- 4. Appointment and supervision of the staff.
- 5. Formulation of the rules and regulations in the interest of activities of the Trust.
- 6. Implementation and execution of the resolutions of General body.
- 7. Prepare, update and submit the list annual body members to the regional / zonal assistant of society alongwith the updated statement of estates and modifications in the body.

- 8. Update and submit every year the list of members, staff and the code of conduct of staff, as per the provisions of Annexure 2 to the Registrar.
- 9. Update the accounts with audit and submit / present to the General Body.
- 10. Appointment of sub-committees or certain member(s) for the execution of special task(s).
- 11. At least two third (2/3<sup>rd</sup>) of the total strength of all types of Members will be conditional as quorum for the meeting, otherwise the meeting will be conducted after half an hour, without quorum.

# 18. Fund raising and utilization :

The Trust shall make use of the funds received through membership fees, donations, government grants, as well as the amount in balance, for the activities of aims and objectives of the Trust.

#### **19. Provision of expenditure :**

The funds of the Trust will be incurred on the activities relevant to the aims and objectives, as per the need and extent of the activity, subject to pre- or post- facto sanction by the Executive Body.

#### 20. Loans and deposits :

The Trust shall demand loans or deposits from any individual, with the permission of the Commissioner (Trusts and Societies).

#### 21. Sale of the estates :

The Trust shall be entitled for sale and purchase of the estates, on approval by the consensus of Executive Body. However, the permission of Commissioner (Trsuts and Societies) is essential for the sale of estates.

# 22. Bank accounts :

The Trust shall open account in any authorized bank as per the provisions of the Act. The withdrawals will be executed with the joint signatures of the Chairman and Secretary only. However, as per the new amendment, for the urgent requirements of local activities and execution, the amount can be withdrawn from an account in Nationalised Bank under the joint names of the Secretary and Deputy Secretary, within the financial rights to Secretary.

# 23. Mode of listing the members :

A list of the members as per the provisions in para 15 in the SRA 1860, will be maintained as per the provisions and regulations in para 15 of SRA (Maharashtra) 1971, in addition to the provisions in list 1, 2 and 6 with the signatures of the members. (Enclosed)

# 24. Trust deed and the provision of amendments :

The rules and regulations of Trust Deed can be made and / or amended as per the need, on approval by  $3/5^{\text{th}}$  of the total strength of members and following the procedures laid down in the para no. 12 of the SRA 1860.

## 25. Irrevocability :

Sudhakarrao Kulkarni Smruti Pratishthan, being an irrevocable trust since its inception, the control and power of the assets under it cannot be transferred with the settler and hence it cannot be altered. In this manner it is irrevocable.

26. Application of income and trust funds :

The funds / property of the Sudhakarrao Kulkarni Smruti Pratishthan wii be used only for the Aims and Objectives of the Sudhakarrao Kulkarni Smruti Pratishthan.

27. Beneficiaries :

The beneficiaries of the activities and achievements of Sudhakarrao Kulkarni Smruti Pratishthan are not any individuals or only a specified section of the society, but the beneficiaries are section of public at large.

## 28. Change in the name of the Trust or amendment in the aims and objectives :

The name of the Trust can be changed or the co-alliance of the Trsut can be approved as per the procedures and conditions laid down in the rule no. 12 or 12A of the SRA 1860.

#### **29. Dissolution of the Trust :**

The dissolution of the Trust can be done with the approval by  $3/5^{\text{th}}$  of the total strength of the members, after settlement of all the accounts and offering donation of the remainder, if any, to the other Trust / organisation, as per the procedures and conditions laid down in the rule no. 13 and 14 of the SRA 1860.
